| <p>This Patient Reminder Card contains important safety information that you need to be aware of before and during treatment with Remsima.</p> <p>When starting a new card, please keep this card as a reference for 4 months after your last dose of Remsima.</p> <p>Please read the Remsima 'Package Leaflet' carefully before you start using this medicine.</p> <p>Keep this card with you for 4 months after your last dose of Remsima, or in case of pregnancy, for 12 months after the birth of your baby. Side effects may occur a long time after your last dose.</p> | <p> Infections </p> <p>Before treatment with Remsima</p> <ul style="list-style-type: none"> Tell your doctor if you have an infection even if it is a very minor one. It is very important that you tell your doctor if you have ever had tuberculosis (TB), or if you have been in close contact with someone who has had TB. Your doctor will test you to see if you have TB. Ask your doctor to record the type and date of your last screening(s) for TB on the card. Tell your doctor if you have hepatitis B or if you know or suspect you are a carrier of the hepatitis B virus. | <p>During treatment with Remsima</p> <ul style="list-style-type: none"> Tell your doctor straight away if you have signs of an infection. Signs include a fever, feeling tired, (persistent) cough, shortness of breath, weight loss, night sweats, diarrhoea, wounds, dental problems, burning when urinating or 'flu-like' signs. | <p> Pregnancy, Breast-feeding and Vaccinations </p> <ul style="list-style-type: none"> In case you have received Remsima while you were pregnant or if you are breast-feeding, it is important that you inform your baby's doctor about it before your baby receives any vaccine.
